



Assessing Africa and Global Palliative Care Development

The project is part of the next edition of the African Atlas of PC and The World Map of PC, directed by Prof. Carlos Centeno and Dr. Vilma Tripodoro. This evaluation will follow the new [WHO conceptual model and its corresponding indicators](#) to address the current global situation of PC development, starting with Africa.

What is it required from you?

A) An **online survey**: 14 indicators explored through 25 questions, with an expected time of 1 – 2 hours for completion (available in English, French and Spanish).

B) Optional participation in an **online free course** to capacitate you as an in-country Consultant in the Global Assessment and Monitoring of National Palliative Care Development. It will introduce the new WHO framework of PC development, the indicators to assess the national situation, and potential data sources (available in English, French and Spanish).

- Mentors will be available online for doubts.
- Survey is embedded in the course and its completion is the result of the course. In case you do not want to do the course, we will provide you with a separate questionnaire.

What are the benefits for you?

A) We will **acknowledge your contribution** in any publications (unless you say the contrary)

B) A diploma of **Consultant in the Global Assessment and Monitoring of National Palliative Care Development** accredited by the University of Navarra (25hs).

C) You will be part of a **global network of PC consultants** that, in the long term, will encourage discussion on progress and impact on the delivery of PC.

D) We will **publish and disseminate any information about the development of PC in your country** through a [country report](#) and a [cartographic open-access web tool](#).
